COG Operating LLC., respectfully requests to chip seal the existing approved caliche oilfield road from the intersection of Buck Jackson Road south to section 30, T. 24S., R. 32E. into the Windward lease. The rights-of-way for the road and to chip seal it from Buck Jackson Road to the lease line has already been approved. This sundry will approve it from the west section line to the east section line on the top end of section 30, following the existing lease road. A chip seal procedure and map is attached to this sundry. It will consist of: 1) prep sub grade, pull shoulders in and create crown on road, 2) set three 24-inch culverts for surface line crossings and water drainage, 3) Top out road with a 6-inch cap of caliche and compact, 4) Stock pile 5/8 chips on various strategic COG locations, 5) Spray road with PEP primer 25/100th, 6) Place HFE oil on road and 1 lift of 5/8 chips, 7) Compact and de-mobilize.

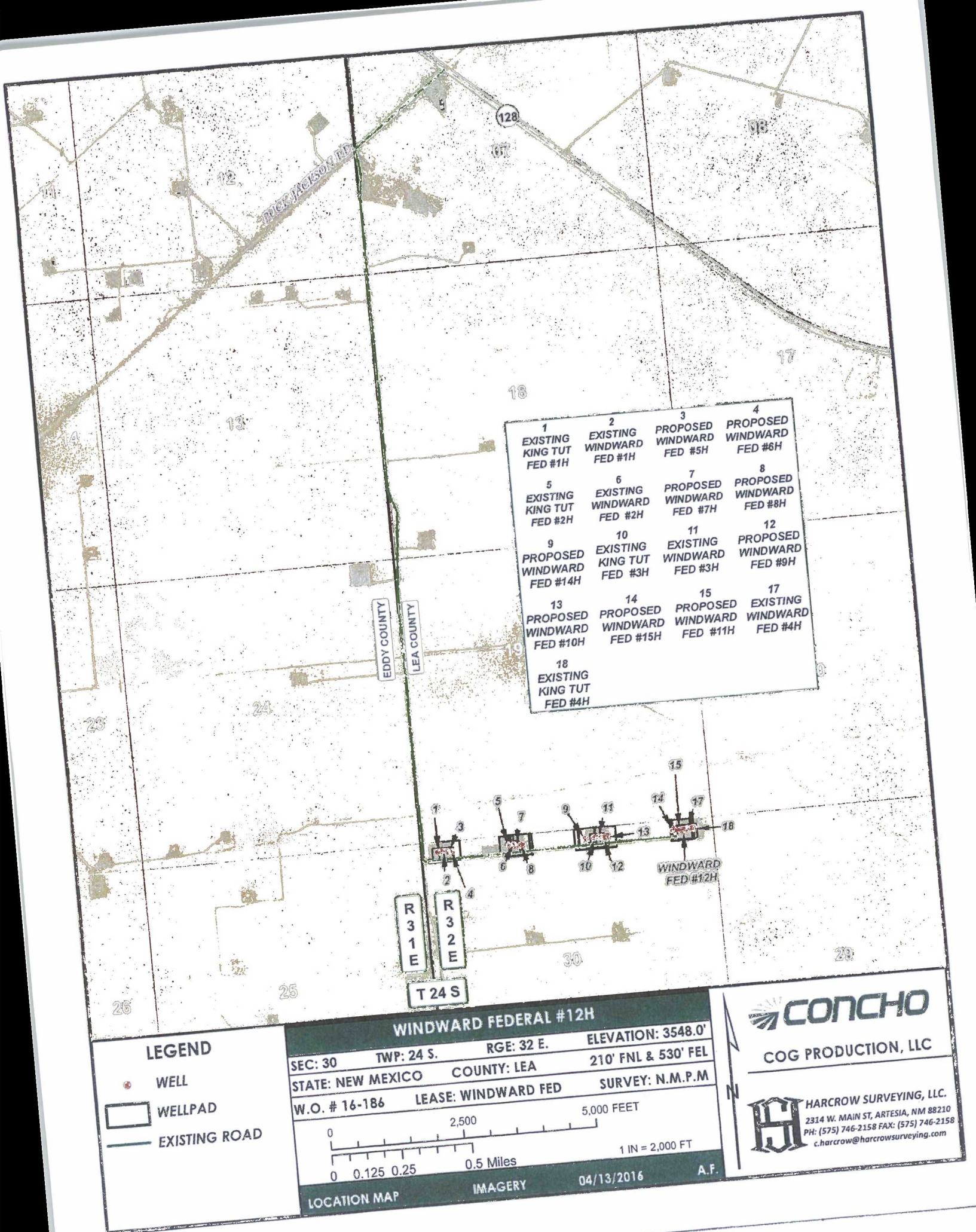

#### Windward Road Chip Seal Process

1. Prep sub grade, pull shoulders in and create crown on road.
2. Set 3 24 inch culverts for surface line crossings and water drainage.
3. Top out road with a 6 inch cap of caliche and compact.
4. Stock pile 5/8 chips on various strategic COG locations.
5. Spray road with PEP primer 25/100<sup>th</sup>
6. Place HFE oil on road and 1 lift of 5/8 chips.
7. Compact and de mobilize.





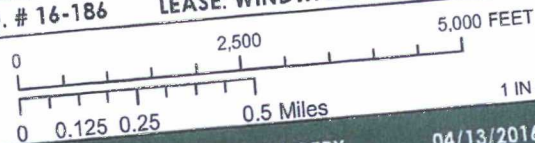
