McElvain is requesting permission to flare gas at this well for a short period of time. The wellbore has been charged with nitrogen to protect it from upcoming fracturing operations on 3 Bone Spring wells in the immediate vicinity. The flaring should begin sometime around January 2, 2018 and is estimated to last for no more than 60 days. Flaring is required because the gas will be non-marketable due to the high nitrogen content (> 4% by contract). This is an experimental procedure so we are unsure how long it will take the nitrogen to dissipate from the gas streams to a marketable level. As soon as the gas composition deems it to be marketable again the gas will return to onsite sales.

Condition of Approval to Flare Gas

1. Approval not to exceed 180 days from date of submission unless otherwise specified in Sundry Notice.
2. All flaring under this request is considered to be "avoidably lost":
Volumes flared beyond limits defined in 43 CFR 3179.7 are considered "avoidably lost" and will require payment of royalties, unless an exception is granted in accordance with 43 CFR 3179.
Volumes for avoidably lost gas shall be reported on OGOR "B" reports as disposition code "08".

Exceptions:

- a. The first 24 hours of a temporary emergency flare is considered "unavoidably lost" and is therefore royalty free. Flared volumes that are considered unavoidably lost are not to be included in Sundry Notice (Form 3160-5). These Volumes are not royalty bearing and shall be reported on OGOR "B" as either disposition code "21" or "22".
- b. If the operator believes that the flared volumes were "unavoidably lost", the operator can submit a request via Sundry Notice (Form 3160-5) with justification for an exception in accordance with 43 CFR 3179.4, 3179.103 - 3179.105.
