Drill 9-7/8" hole to 9965'. 6/7/18 RIH & set 7-5/8" 29.7# L-80 BTC csg @ 9954', DVT @ 6583', ACP @ 6589', pump 45bbl spacer then cmt w/ 280sxs (138bbl) class H w/ additives 11ppg, 2.75 yield followed by 170sxs (51bbl) class H w/ additives 13.2ppg 1.67 yield, full returns throughout job, inflate ACP to 2076#, open and circ thru DVT, circ 168sks (50bbl) to surf. Pump 2nd stage w/ 20bbl spacer then cmt w/ 1870sxs (576bbl) class H w/ additives 13.5ppg 1.73 yield, full returns while pumping cmt but lost returns during displacement. No cmt to surface, notified Mustafa Haque at BLM and was instructed to run a temp survey, WOC. 6/8/18 RU logging truck, run temp survey, TOC=3976'. Install pack-off, test to 5000#, good test. Install wellhead cap and rig release to Mesa Verde BS Unit 12H.
