Pump 50bbl spacer, then cmt w/ 340sxs (166bbl) class C w/ additives 11ppg, 2.74 yield followed by 825sxs (242bbl) class C w/ additives 11ppg, 1.65 yield. Full returns throughout job, 112sxs (40bbl) cmt to surface. RD, rig release 6/26/18.
