The first OHE line will be 813.5 feet in length, 30.0 feet in width, running from our Mesa Verde truck loading station pad to a tie-in point as seen on the attached plats, crossing BLM lands in Section 18, T24S-R32E, Lea County, NM.

The second OHE line will be 1,214.7 feet in length, 30.0 feet in width, running from our Mesa Verde AST pad to a tie-in point as seen on the attached survey plats, crossing BLM lands in Section 18, T24S-R32E, Lea County, NM.

The third OHE line will be 602.6 feet in length, 30.0 feet in width, running from our gas
