Spotted 25 sx class C cmt w/2% CACL @ 2510'-2148'. WOC. Tagged plug @ 2118'. Perf'd csg @ 1900'. Squeezed 25 sx class C cmt @ 1900'-1750'. WOC. 08/16/18 Tagged plug @ 1700'. Perf'd csg @ 100'. Squeezed 25 sx class C cmt @ 100' & circulated to surface. Rigged down and moved off. 08/17/18 Moved in backhoe and welder. Dug out cellar. Cut off well head. Welded on "Above Ground Dry Hole Marker". Backfilled cellar. Cut off Deadmen. Cleaned location, moved off.
