The total length and disturbance of all three lines within the same ditch on federal and state lands across section 25, T. 25S., R. 33E. will be 11,889.5 ft. (2.25 mile) in length, 30 ft. in width for a surface disturbance of 8.19 acres. The 4-inch poly buried gas lift pipeline on BLM surface will be 2,810.9 ft. (0.53 mile) in length, 30 ft. in width for a surface disturbance of 1.94 acres. The 4-inch poly buried gas lift pipeline on state surface will be 495.5 ft. (0.09 mile) in length, 30 ft. in width for a surface disturbance of 0.34 acres. The total disturbance for the 4-inch poly buried gas lift pipeline will be 3,306.4 ft. (0.63 mile) in length, 30 ft. in width for a surface disturbance of 2.28 acres. The 6-inch poly
