10/15/2018 Cleared location. Move in equipment and rig up. Unseated pump and laid down 28 ¾" rods and 48 5/8" rods. 76 Total. Installed BOP and POOH with tubing. Stood back 56 joints and laid down 7 joints with holes. 63 total.

10/16/2018 Made gauge ring run to 1910'. Set CIBP at 1894'. Pumped MLF with no circulation to the pit. Spotted 50 sx cement on top of CIBP. Caught circulation while pumping cement. POOH and WOC. Tagged cement at 1691'. POOH to 1209'. Established circulation with 11 bbls and spotted 50 sx cement with CaCl. POOH and SION.

10/17/2018 Tagged cement at 1016'. POOH to 100' and established circulation with 15 bbls. Circulated cement to surface with 25sx. Laid down remaining pipe and rigged down. Dug out and cut off. Cement had fallen estimated 300' from surface. Called OCD. Dumped 2 yards of gravel and filled 7" casing to surface with 30 sx w/CaCl. Cement remained at surface. Installed marker, cleaned pit, cut off anchors, and cleared location.
