9/24/2018 Cleared location. Moved in rig and rig up. Dug out, installed wellhead, and installed BOP. Made gauge ring run to 1970'. Set CIBP at 1950'. Picked up workstring. Circulated MLF and tested casing to 600#. Casing good. Spotted 50 sx cement on top of CIBP. POOH and SION

9/25/2018 Finish laying down pipe and perforated at 478'. Pumped down 5 ½" casing and pressured up on perfs to 500# and held. RIH with tubing to 533' and circulated cement tot surface with 60 sx. Lay down pipe and rig down. Dug out and cut off wellhead. Filled up 5 ½" casing and pumped 25 sx down 5 ½" X 8 5/8" annuls. No cement to surface. Pumped 35 sx down annulus with CaCl. Still no cement to surface. SION to let cement set. Cleaned steel pit.

9/26/2018 Filled up annulus with 45 sx cement with CaCl. Cement remained at the surface. Installed marker and cleared location.
