

2. Make gauge ring run and set 5 1/2" CIBP at 1759'. Circulate MLF and test casing to 500#.
3. Spot 50 sx cement on top of CIBP.
4. Spot cement from 411' to surface.
5. Cut off wellhead 3' below ground level.
6. Install upright marker and cut off anchors.
