### **Gathering System and Pipeline Notification**

The wells will be connected to production facilities after flowback operations are complete so long as the gas transporter system is in place. The gas produced from the production facilities should be connected to an Energy Transfer Partners gathering system. It will require ~750' of pipeline to connect each facility to the Energy Transfer Partners gathering system. Matador Production Company periodically provides a drilling, completion and estimated first production date for wells that are scheduled to be drilled in the foreseeable future to Energy Transfer Partners. #### Flowback Strategy

After the fracture treatment/completion operations (flowback), the well(s) will be produced to temporary production tanks and the gas will be flared or vented. During flowback, the fluids and sand content will be monitored. When If the produced fluids contain minimal sand, then the wells will be turned to production facilities. The gGas sales should start as soon as the wells starts flowing through the production facilities, unless there are operational issues on the midstream Longwood Midstream Delaware, LLC's system at that time. Based on current information, it is Matador's belief the system can will be able to take their gas upon completion of the well(s).

Safety requirements during cleanout operations from the use of underbalanced air cleanout systems may necessitate that sand and non-pipeline quality gas be vented and/or flared rather than sold on a temporary basis.

#### **Alternatives to Reduce Flaring**

Below are alternatives considered from a conceptual standpoint to reduce the amount of gas flared.

- Power Generation On lease
  - Operating a generator will only utilize a Only a portion of the produced gas and operating the generator the, remainder of gas would still need will to be flared.
  - O Power Company has to be willing to purchase gas back and if they are willing they require a 5 year commitment to supply the agreed upon amount of power back to them. With gas decline rates and unpredictability of markets it is impossible to agree to such long term demands. If the demands are not met then operator is burdened with penalty for not delivering.
- Compressed Natural Gas On lease
  - o Gas flared would be minimal, Compressed Natural Gas is likely to but might be uneconomical to operate when the gas volume declines.
- NGL Removal On lease
  - o NGL Removal requires a pPlants and isare expensive on such a small scale rendering it uneconomic and stills requires residue gas tois bestill flared, and uneconomical to operate when gas volume declines.
