2/5/2019 Move rig to location

2/6/2019 Rig up and move in equipment. Bled down tubing and pumped 15 bbls brine. Tubing went on vacuum. Installed BOP and released packer. Shut down for high winds.

2/7/2019 Shut down for weather

2/8/2019 POOH with 238 joints of tubing. Set CIBP at 7600' with wire line. RIH with tubing to 7600'. Circulated hole with MLF and tested casing to 500#. Casing was good. Spotted 25 sx Class H cement on top of CIBP. POOH to 6582' and shut down.

2/18/2019 Spotted 50 sx cement at 6582'. ETOC @ 6076'. POOH to 4515' and spot 25 sx cement. ETOC @ 4262'. POOH to 2515' and spot 25 sx cement. ETOC @ 2259'. POOH to 1850' and spot 25 sx cement. ETOC at 1597'. Laid down remaining pipe and perforate at 400'. Closed BOP and established circulation. Pumped cement down 5 1/2" casing to perfs at 400' and up the annulus to surface. Took 110 sx. Rigged down.

2/19/2019 Dug out the cellar and cut off wellhead. 8 5/8" casing was full and filled up 5 1/2" casing with less than 1 sack of cement. Installed marker and cut off anchors. Filled in cellar and cleared the location. Cleaned steel pit and moved equipment out.
