On 12/15/2018, Enstor conducted pre-workover diagnostics on Grama Ridge GRM Unit #8 Well which included pressure testing the tubing / casing annulus per MIT testing guidelines and also pressure testing the injection / withdrawal tubing to confirm integrity. Both tests were successful and were witnessed and approved by John Staton, Petroleum Engineer Technician with the BLM.

Immediately following the test, MIT results were communicated to BLM Petroleum Engineer, Mustafa Haque, via telephone along with Enstor's plan to move forward with coiled tubing cleanout / stimulation operations. BLM granted approval both over the phone and in a follow up email on 12/17/2018.

Once cleanout / stimulation operations are complete, GRM Unit #8 will be placed back into active injection / withdrawal service.

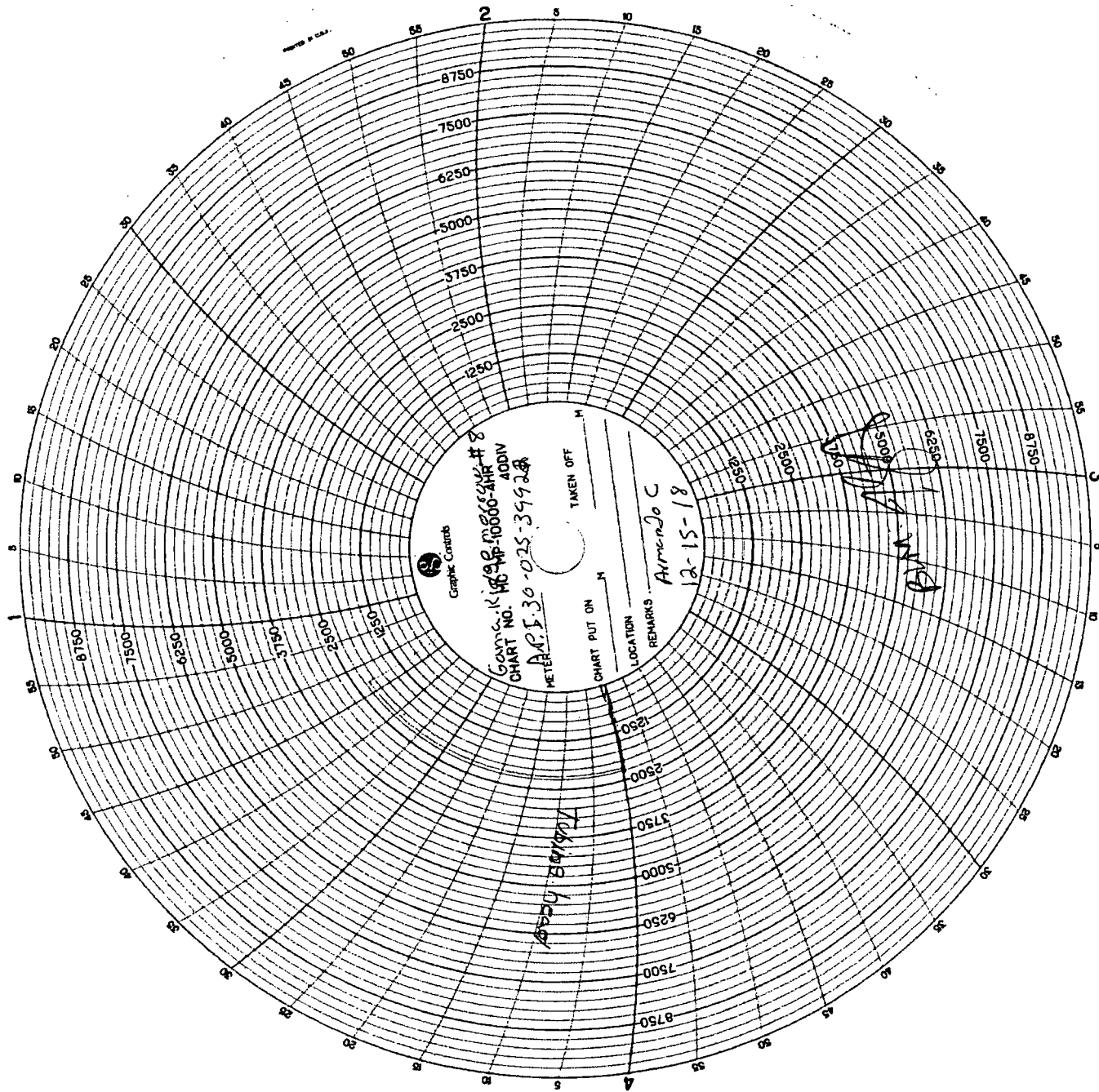
