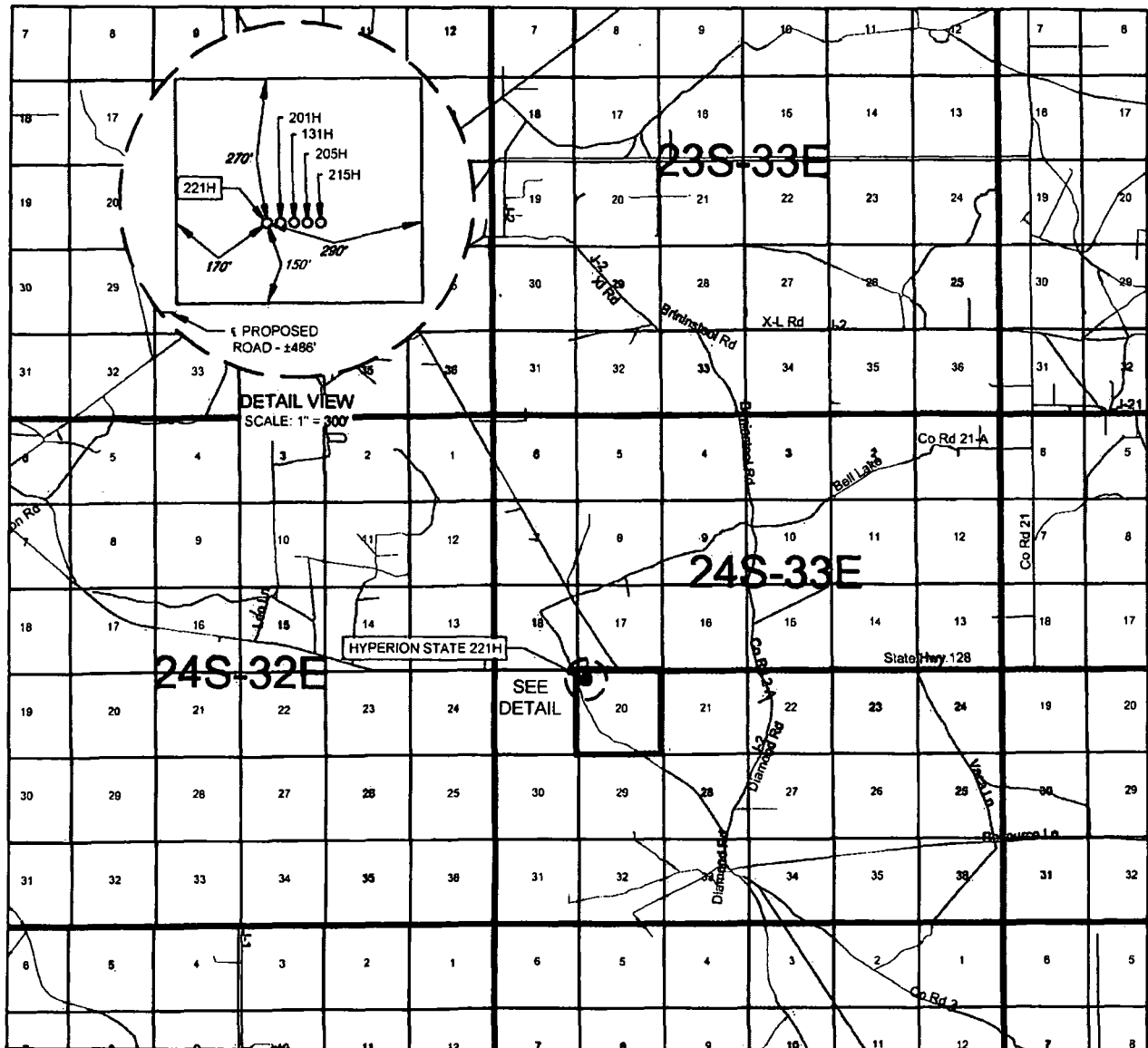

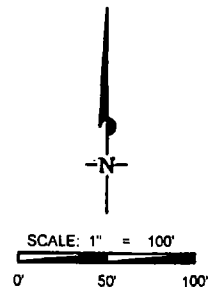
SECTION 20, TOWNSHIP 24-S, RANGE 33-E, N.M.P.M.
