Conditions of Approval

1. Approval is for coriolis meter: #24: Model No. 83F80-KQW2/0 – Serial No. JC0A3916000.
Provide beginning totalizer reading prior to first load of oil being sold through meter.
2. The metering facility shall include a temperature probe to monitor the actual oil temperature during custody transfer. This information will be recorded and used in calculating the volume of oil metered during each transaction.
3. The meter shall have a non-resettable totalizer.
4. The custody transfer meter shall be proven during its first load of oil measured from the Magnolia 15 Fed Com East CTB and in conformance with 43 CFR 3174 as appropriate. Meter proving records shall be maintained for a period of six years from the date of generation and will be made available for audit upon request.
5. A copy of the monthly meter proving will be submitted to the appropriate BLM office within 30 days of proving.
6. The run ticket associated with each oil transfer shall include the measured or calculated BS&W, oil gravity, temperature recorded during the transfer and beginning & ending totalizer readings. Such records shall be maintained for a period of six years from the date of generation and will be made available for audit upon request.
7. A copy of run ticket shall be submitted to the appropriate BLM office within 30 days of ticket generation and will be made available for audit upon request.
8. Operator to maintain tank gauging data to be used as a comparison with the LACT meter readings.
9. This approval may be subject to future review and if determined inadequate with regards to accurate measurement, the approval will be withdrawn.
