Run 11,600' of 4.5" 13.5# P-110 BTC production casing as a tieback string and tie into the top of the existing liner hanger at 11,600' MD.

The tieback string will be cemented in place using 660 sacks of 14.8 ppg tail cement (1.14 ft³/sk) with TOC planned at 4,000' MD.
