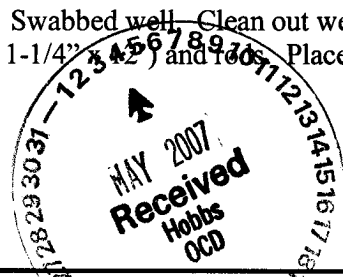

RIH w/CIBP set at 3000'. Test to 2000# - ok. Perf additional Eumont from 2553-2974' w/37 holes w/3-1/8" select fire gun loaded with 19 gram charges, 1 SPF (.46" hole size). Acidize perfs (2553-2974') w/3500 gals 15% HCL acid dropping 74 7/8" ball sealers.

Frac well (2553-2974') with 150,000 pounds 12/20 sand with 54,200 gals Lightning 2500. Swabbed well. Clean out well to CIBP. Drill out CIBP at 3000'. TIH w/113 jts 2-3/8" tbg set at 3591'. TIH w/pump (2" x 1-1/4") and 100'. Place well back on production.
