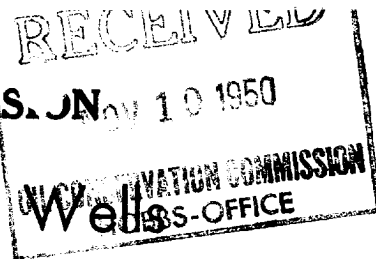

**3063' - Total Depth - line. Run Temperature Survey - Top of cement on outside of 8-5/8" casing at 1665', ratio of actual to calculated fill 47.3%. Checked top of cement at 3789'. Tested casing & connections with 1200# for 1/2 hour - no pressure drop. Drilled cement from 3789' to 3063' & tested casing & connections with 1200# for 1/2 hour - no pressure drop. Started drilling formation and 7-3/8" hole at 9:45 P.M., 11-6-50.**
