

MULTI-POINT SURFACE USE AND OPERATIONS PLAN

WOLFSON OIL COMPANY
MOUNTAIN-FEDERAL NO. 2
990' FEL & 2310' FNL
T-7-S, R-32-E
ROOSEVELT COUNTY, NEW MEXICO
LEASE NO. NM-18846

This plan is submitted with the Application for Permit to Drill the above captioned well. The purpose of this plan is to describe the location, construction activities, and operations plan.

1. EXISTING ROADS:

- A. Exhibit No. 1 is a portion of a map showing the proposed well as staked. To reach the proposed well, go to Kenna, New Mexico, then turn south approximately nine (9) miles to a fork in the road; then take the left fork and go approximately five and eight-tenths (5.8) miles; stake is almost on road and can be easily seen by going on road to No. 1 well and looking west.
- B. Exhibit No. 2 is a plat showing existing roads.

2. PLANNED ACCESS ROAD:

- A. Length and Width: There will be no new road necessary for the No. 2 Well.

3. LOCATION OF EXISTING WELLS:

See Exhibit 3.

4. LOCATION OF EXISTING FACILITIES AND PROPOSED NEW FACILITIES:

A. Existing Facilities: None.

B. Proposed Facilities: Tank battery will be located approximately on southeast corner of location.

5. LOCATION AND TYPE OF WATER SUPPLY:

Water for drilling will be purchased from surface owner and trucked to location (approximately 5 miles).

6. SOURCE OF CONSTRUCTION MATERIALS:

Caliche will be purchased from surface owner (approximately 5 miles).

7. METHODS OF HANDLING WASTE DISPOSAL:

A. Drill Cuttings: Drill cuttings will be disposed of in drilling pits.

B. Drilling Fluids: Drilling fluids will be allowed to evaporate in pits until dry.

C. Formation Water and Oil: Any produced water will be disposed of in drilling pit. Oil will be stored in tanks and sold. Produced water will be stored in water tank when battery is constructed.

D. Human Waste: All current laws and regulations pertaining to above will be complied with.

E. Trash, Waste Paper, Garbage and Junk: All trash, waste paper, garbage and junk will be buried in trash pit shown on location plat.

F. Trash Burial: All trash and debris will be buried or removed within 30 days after completion.

8. ANCILLARY FACILITIES:

None required.

9. WELLSITE LAYOUT:

A. Wellsite Boundaries: The boundaries have been staked and flagged.

- B. Rig Components: Exhibits Nos. 4 and 5 show the relative location and dimensions of the well pad, pits, and major rig components.

10. PLANS FOR RESTORATION OF SURFACE:

- A. Equipment Removal: All drilling equipment will be removed after the casing is set. Pits will be filled and location leveled and cleaned after pits are dry.
- B. Unguarded Pits: Pits will be fenced if they are a potential danger to cattle.
- C. Well Abandonment: Upon abandonment, the restoration will be in accordance with the wishes of the surface owner, Mr. Tommy Tucker of Elida, New Mexico.

11. OTHER INFORMATION:

- A. Topography: The drillsite is located in relatively flat country with minor crenulations due to very small dunes.
- B. Soil: The surface is sandy with small dunes.
- C. Flora and Fauna: The vegetative cover is very sparse and consists of weeds, cacti and very little native range grass. Wildlife is typical in the area with few rabbits, coyotes and rodents.
- D. Ponds and Streams: None.
- E. Residences: The nearest occupied dwelling is approximately two to three miles northwest. The closest water is probably at the ranch house.
- F. Archeological, Historical and Cultural Sites: None.
- G. Land Use: Very poor grazing land.
- H. Surface Ownership: Wellsite is on surface land owned by Tommy Tucker of Elida, New Mexico.
