Well spudded 8-2-55. Drilled w/rotary tools 17-1/2" hole to 436', reduced to 12-1/4" & drilled 436-745', rebeds. Ran 439.16' of 13-3/8" OD 48# 8rd thd ST&C J-55, 1 condition, casing set at 436'. Cemented w/450 sx Longhorn portland regular cement. Plug pumped to 400', circulated out 20 sx. Tested casing before & after drilling out cement plug w/500# for 30 minutes - no pressure losses.
