Well spudded 3/5/64 at 12:45 PM. Drilled 11" hole to depth of 385' and ran 18 jts 2 1/4" 8-5/8" casing to 385' depth, set same w/175 sx cement, 100 sx 2% gel, and 75 sx reg. neat w/2% Cal.Ch. Total pipe in hole 372'. Let cement set 18 hours, then pressured up to 1000# to test. Pressure held for 30 minutes test period with no pressure drop logged. Drilling ahead making 6-3/4" hole.
