Plug and abandon as per the following procedure: POOH w/rods, pump, tbq and tbq anchor. Using electric wireline set CIBP at 7400' and cap w/35' cement. Load hole with 9.5#/gal mud. Perforate 5 1/2" casing at 5050'. Set cement retainer at 4950'. Squeeze 100 sx cement to get cement 50' above and below 9 5/8" casing shoe. Pick up out of retainer prior to squeezing last 5 sx and drop on retainer for 35' cap. Load hole with 9.5#/gal mud. Spot 20 sx cement at 100' to surface.* Weld on cap and erect permanent abandonment marker.

* CEMENT TOP 50' OF 9 5/8" - 13 3/8" CASINGS ANNULUS.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
