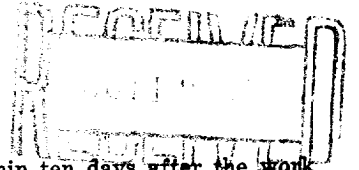

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On Sept. 27, 1949, we ran 7" OD seamless J-55 20# new casing to 4378', and cemented it, by Halliburton, with 100 sacks of cement.

On October 2, 1949, the cement plug was drilled and the hole bailed dry. No water appeared in the hole, and the cement job appeared satisfactory.
