Detailed account of work done, nature and quantity of materials used, and results obtained.

Drilled to 3970', ran 127 joints of 7-5/8", 26.4 lb. casing, set at 3970'. Cemented with 250 sx. of 50-50 Pozmix. Bumped plug with 2000 psi at 10:25 P.M., 10/18/63. WOC for 24 hours - pressured to 1500 psi with rig pump - held okay. Drilled shoe with 6-3/4" bit - drilled 6-3/4" hole to 8975' KB (driller). Logged hole (log TD 8985') and ran 5-1/2" 17 lb. N-80 casing as liner. Set casing at 8976', top of liner at 3871', cemented with 100 sx. 50-50 Pozmix with 6 lb. salt per sx. Bumped plug with 2000 psi, held okay. Set liner seal, pressured to 1500 psi, held okay. Plug down at 6:00 A.M., 11/18/63.


