Gentlemen:

An Exception to Rule 104 F.I. by administrative approval is requested for Texaco Producing Inc.'s Central Vacuum Unit Well No. 291. This well is located 660' FSL & 1330' FWL, Unit Letter "N", of Section 36, T-17-S, R-34-E.

This well must be drilled in this location to ensure proper development of 10-acre spacing. Wells drilled previously on 10-acre spacing have proven to be viable wells. It will be completed in the Grayburg San Andres formation.

Texaco Producing Inc. is the only "affected offset operator" to this location and we grant ourselves a waiver to the unorthodox location. Attached is Form C-102 and a lease plat showing the location of the subject well.

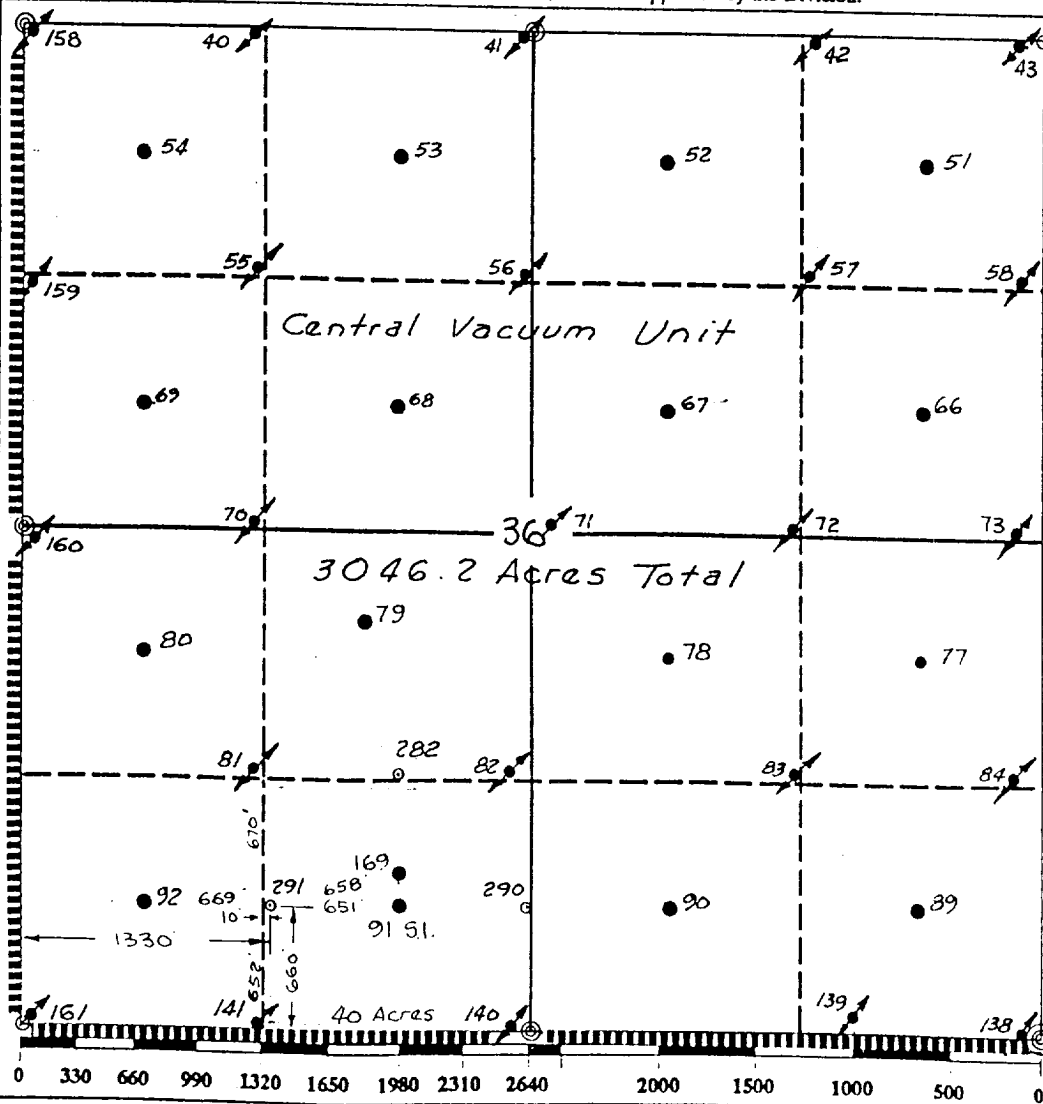

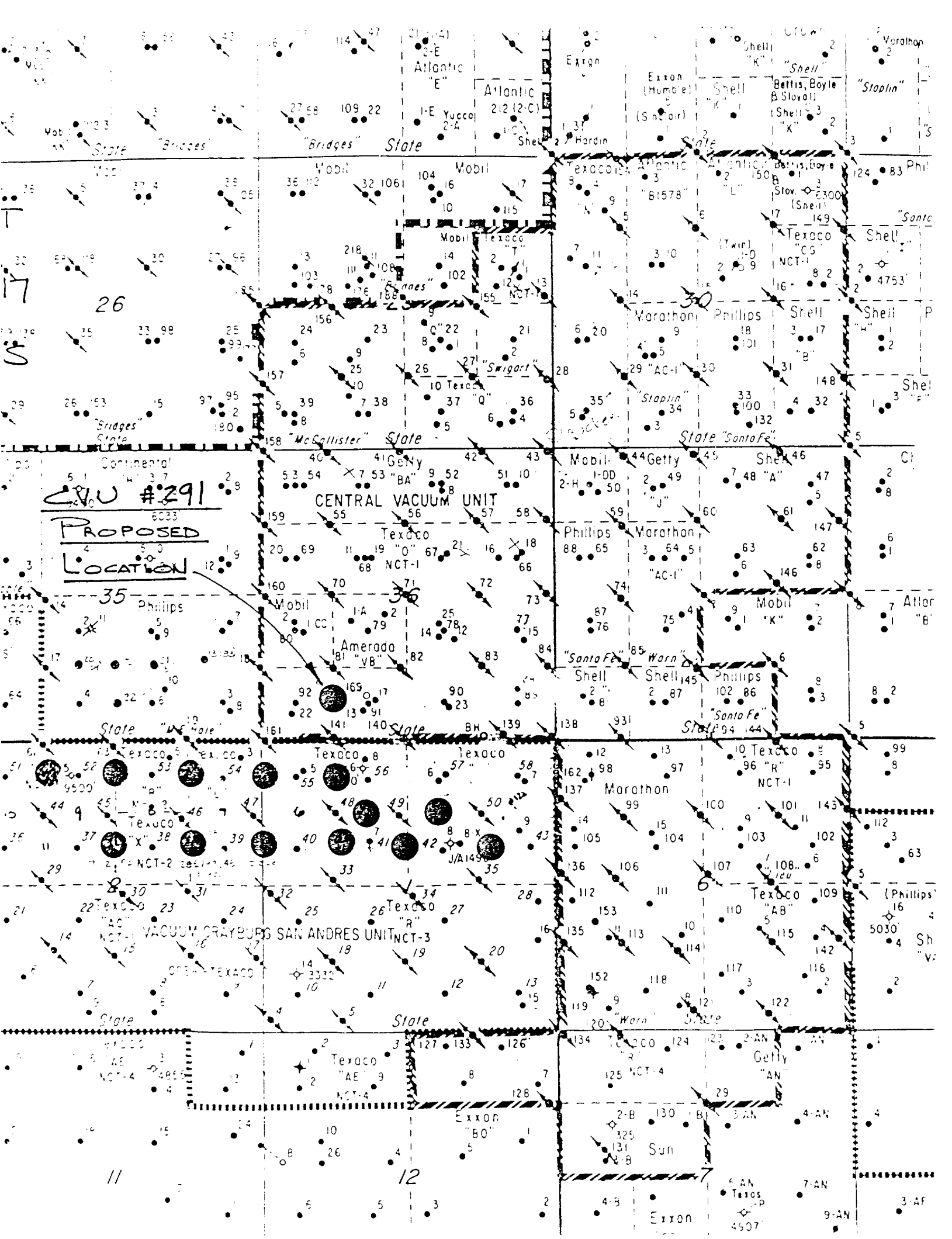
