Spud well 03/17/92. Ran 43 joints of 8-5/8" 24# casing and set at 1,820 feet with 750 sacks of Class "C" cement. Circulate to surface. Waited on cement 12 hours. Tested casing to 800 psi. Held OK.

Ran 118 joints of 5-1/2" 15.5# casing and set at 5,230 feet with 1,050 sacks of Class "C" cement. Circulated cement to surface. Waited on cement greater than 24 hours. Tested casing to 2,000 psi. Held OK. Total depth 5,230 feet.
