DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Finished drilling 8-3/4" hole to 3840' @ 4:15 PM, 11-3-54. Ran 125 jts. of 7" OD Casing set @ 3800'. Cemented with 800 sacks. Pumped plug to 3743' @ 3 PM, 11-4-54. Maximum pressure 645#. Ran temperature survey and found top of cement @ 1925' or 33.78% fill 24 hrs. WOC. Tested 7" OD Casing before and after drilling cement - OK. Drilled plug and cement from 3743' to 3800' and washed open hole. Continued with completion operations.
