Survey @ 967' = 1.00 (Deg.). Drill from 1007' to 1245'. Survey @ 1218' = 1.00 (Deg.). Circ and cond. RU Bull Rogers Csg Crew & run 27 jts of 8-5/8", 24#, J55, 8RD, ST&C, 'A' csg set @ 1245', Shoe @ 1244', FC @ 1198' & ran 7 centralizers. Circ Csg. Cmt w/ BJ: Pump 250 sx of class 'C' + 2% Cacl2 + 1/4#/sx CF (13.7#-1.68). Tailed w/ 200 sx class 'C' + 2% Cacl2 + 1/4#/sx CF (14.8#-1.32). Displace w/ 76 bbl brine water @ 4 bbl/min.
