- 6/10/98: Frac'd Bone Spring perfs 8832' - 8884' with 15,000 gals pad, 20,000 gals Ramp 1-4 PPG, 20/40 SUP DC, 6000 gals 4.6 PPG, SUP DC. Flushed with 5,746 gals. Total sand: 73,900 lbs.
- 6/11/98: Released HES 4 1/2" liner. TOH. TIH with 8500' 2 3/8" N-80 tubing.
- 6/12/98: Cleaned out to PBDT 8975'. Circulated hole clean. Set 2 3/8" N-80 tubing at 8750'. Set 4 1/2" HES liner packer at 8484'.
- 6/15/98: TIH with production rods and pump: 2 x 1.5 x RHDC x 24 x 6. Returned to production.
