**LOCKHART B-14 #2
RECOMMENDATION TO TEMP ABANDON**

This well is currently inactive but has potential in the NEDU water flood

Prepare well bore as follows:

1. POH with existing equipment.
2. Make scraper run to top perf.
3. Set Cast Iron Bridge Plug within 50' of top perf, spot 35' of cement on top of CIBP.
4. Circulate casing with inhibited packer fluid.
5. Pressure test casing to 500# for 30 minutes. Give BLM 24 hrs notice prior to pressure test.
