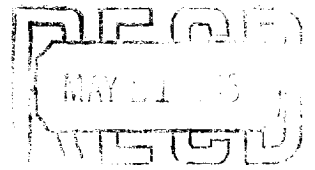

Cement will be allowed to set 36 hours, then tested with 1000<sup>psi</sup> pump pressure for one hour. Casing shut off will be tested on May 19, 1945 at eight o'clock, A.M.
