FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

6570' TD - 5567' DOD - Run 1 1/2" tubing, run gamma ray neutron logs from zero to 6567', Detail logs from 3900' to 6567'. Run 3 1/2" OD EUE Tubing w/packer & set @ 6530'. Sand-oil fracture perforations 6530' to 6565' w/20,000 gallons of lease crude oil and 20,000 lbs. 20-40 sand w/ball sealers and fluid loss control additives, treat with 1000 gallons of 15% regular acid in stages while fracturing, snub test. Pull 3 1/2" tubing and perforate Blinbery oil zone with 2 shots per foot selectively from logs from approximately 5790' to 5920'. Run retrievable bridge plug and packer on 3 1/2" tubing, set bridge plug at approximately 5950', sand-oil fracture perforations from 5790' to 5920' with 30,000 gallons lease crude oil and 60,000 lbs. 20-40 sand with fluid loss additives, treat with 1000 gallons of 15% regular acid in stages while fracturing, snub test. If both zones are commercial, run Model "B" Packer 2 strings of 2-1/16" tubing & complete as a dual oil well.
