Heritage Standard Corporation proposes to plugback this well and attempt a completion in the Strawn reservoir by (1) pulling the 2 7/8" tubing out of the packer set @15,140' (2) set a CIBP at 15,130' in the 7 5/8" liner (3) set a Baker Model "D" Packer in the 7 5/8" liner at 14,200' (4) Trip in hole with 2 7/8" tubing and set in Model "D" Packer (5) perforate Strawn reservoir at 14,270'-14,304' & 15,036'-15,050' (6) acidize Strawn perforations as necessary (7) flow test well and turn well into sales line. Heritage Standard Corporation requests that we be permitted to maintain the well below the CIBP to be set at 15,130' for potential use at a latter date.
