Gentlemen:

TEXACO Inc. respectfully requests administrative approval for the tubingless completion of C. C. Fristoe "a" (NCT-1) Well No. 10 in the Justis Blinbry Pool. This well is located in Unit E, Section 35, Township 24 South, Range 37 East, Lea County, New Mexico.

Surface casing shall consist of 7-5/8 inch pipe set at 1000 feet in anhydrite with cement circulated to surface. Production casing shall consist of 2-7/8 inch pipe set at total depth of 5850 feet, cemented with 450 sacks of Class "C", 8% gel, and 300 sacks of Class "C", 4% gel, cement. The calculated cement volume equals 219% of the calculated annular volume from total depth to the base of the salt expected to occur at 2310 feet.

The New Mexico Oil Conservation Commission has previously approved the tubingless completion in the Justis Blinbry Pool in TEXACO Inc. C. C. Fristoe "a" (NCT-2) Well No. 8 by Administrative Order No. MC-1565. Attached is a diagrammatic sketch of the proposed completion and lease plat. A copy of this application is being sent this date to each offset operator by registered mail.

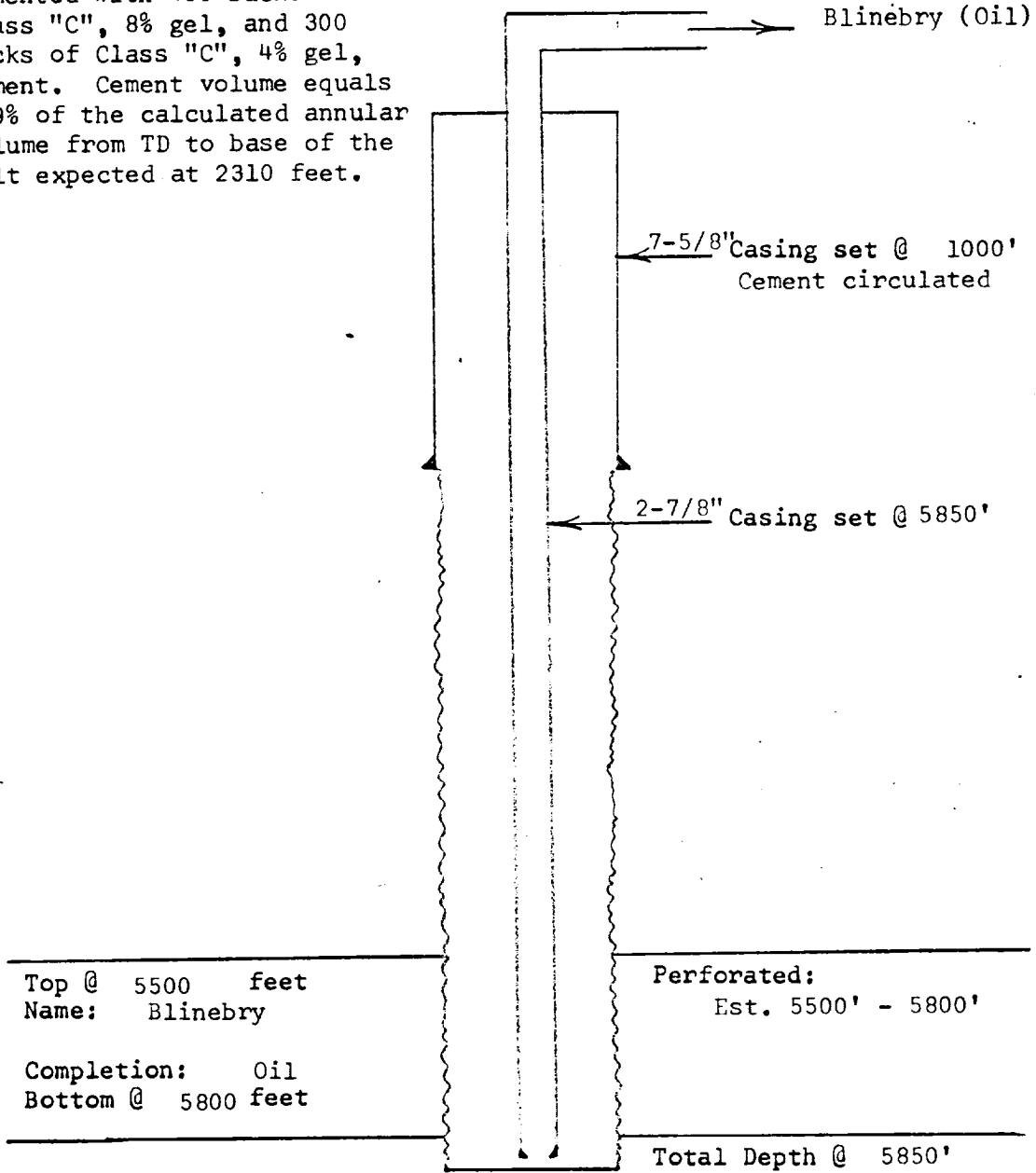

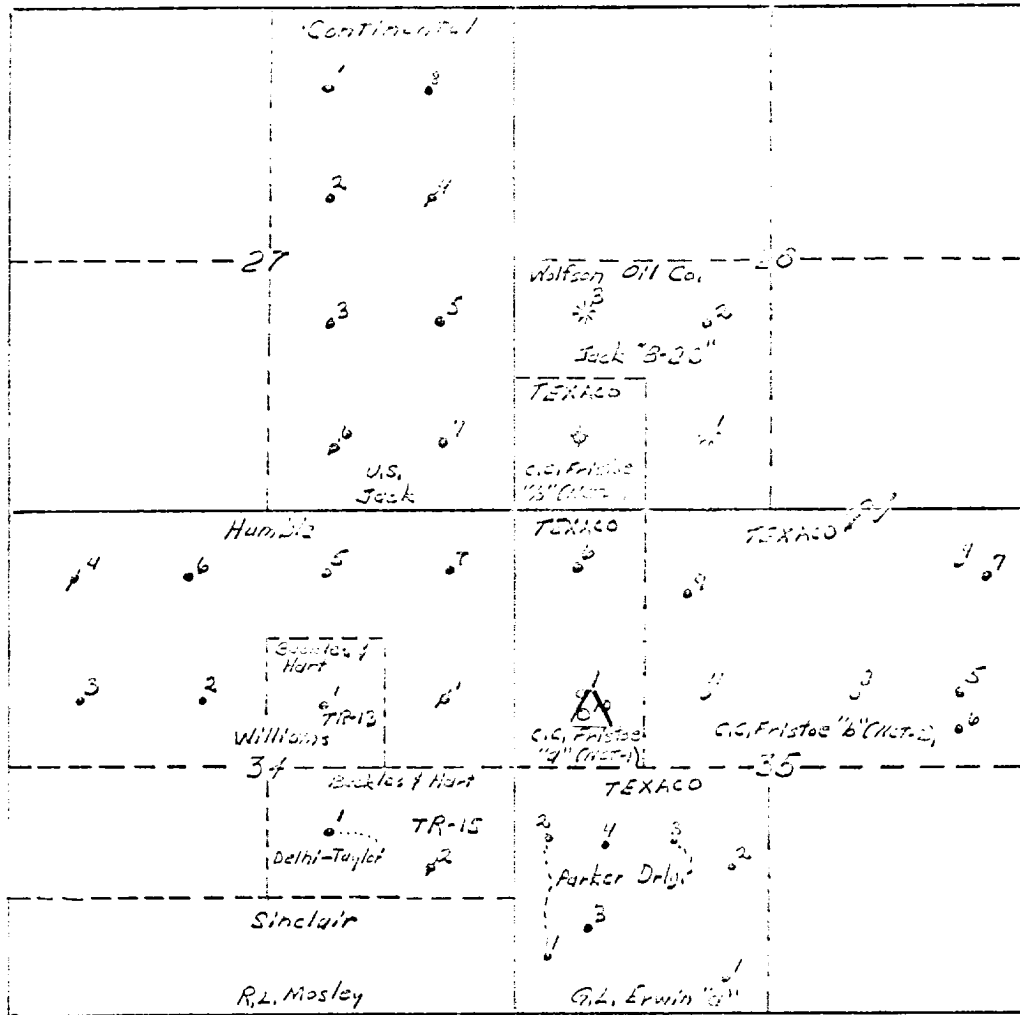
