Attached is a C-107A application to downhole commingle the Blinebry Oil & Gas (Oil-06660), Drinkard (19190), and Wantz-Abo (62700) Pools within Breitburn's Encore M State Well No. 15.

Breitburn proposes that the allocation of production for the Encore M State No.15 be based upon the 2014 average well production from six offset wells. Attached is a table showing 2014 average production from six wells operated by Breitburn that currently produce by downhole commingling in the Blinebry Oil & Gas, Drinkard and Wantz-Abo Pools. This data indicates that the average oil and gas production for 2014 for these wells is as follows:



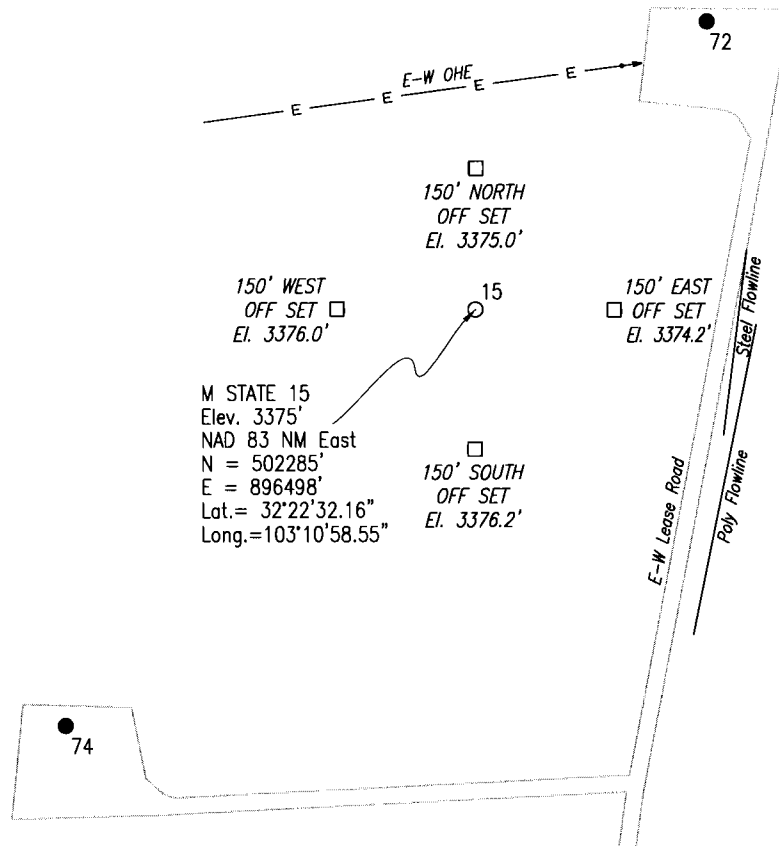

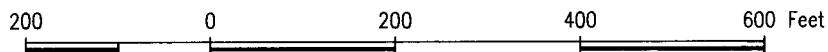
