Matador Production Company (OGRID No. 228937) seeks administrative approval of an unorthodox well location for its Tiger 14-24S-28E RB #204 (API 30-015-43087) to be completed within the Culebra Bluff, Wolfcamp South (Gas) Pool (Pool Code 75750) underlying Section 14, Township 24S, Range, 28E, Eddy County, New Mexico. Attached as **Exhibit A** is a C-102 for the well. This well is a horizontal well that will be drilled as follows:

- Surface Hole Location: 475 feet from the South line and 229 feet from the East line of Section 14 (Unit P);
- First Perforation Point: 660 feet from the South line and 330 feet from the East line of Section 14;
- Last Perforation Point: 660 feet from the South line and 330 feet from the West line of Section 14; and
- Bottom Hole Location: 660 feet from the South line and 240 feet from the West line of Section 14 (Unit M).

Matador Production Company is requesting this NSL in order to efficiently produce its interests in Section 14. This well is producing from the Culebra Bluff, Wolfcamp South (Gas) Pool (Pool Code 75750). There are no special pool rules for this pool, and thus the setback requirements of 660' under Rule 19.15.15.10(B) apply. As a result, the completed interval for this well encroaches on the adjoining spacing units in Sections 13 and Section 15. In



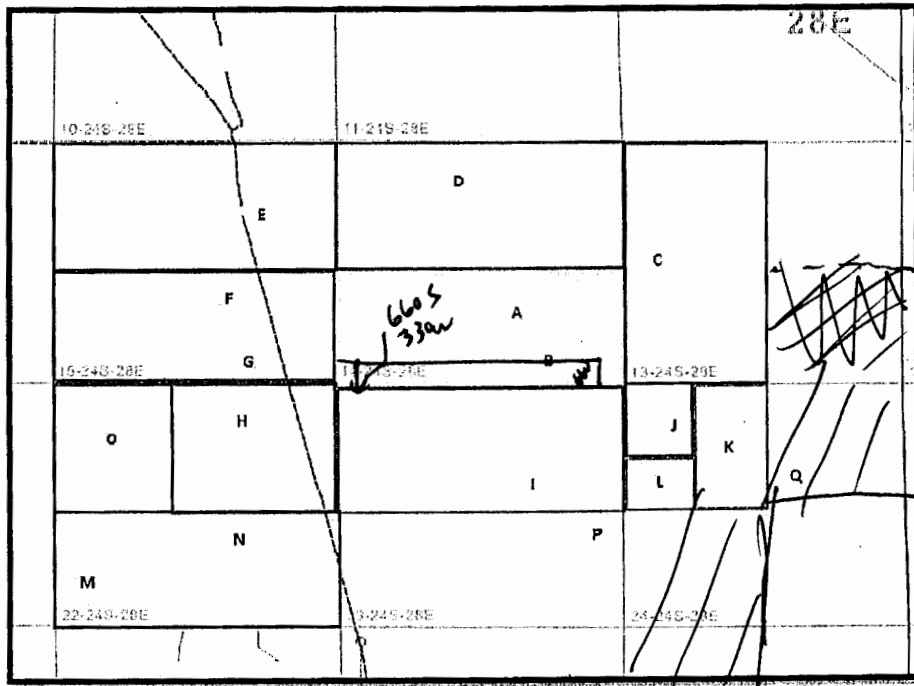

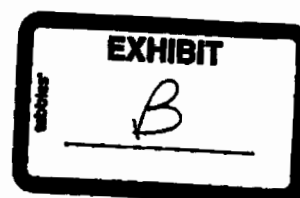
