Dear Mr. Lowe:

Pursuant to Division Rule 19.15.15.13, Mewbourne Oil Company ("Mewbourne") respectfully requests administrative approval of an unorthodox gas well location for its proposed Armstrong 26/35 W0JO Fed Com #4H. This well will be drilled as a horizontal gas well in the Purple Sage Wolfcamp (Gas) Pool (98220).

The Armstrong 26/35 W0JO Fed Com #4H will be dedicated to a standard 480-acre gas spacing and proration unit comprising the SE/4 of Section 26 and the E/2 of Section 35. There are currently two other existing Wolfcamp Gas wells producing from within the proposed spacing unit, the Armstrong 26/35 W0LM Federal Com #1H, API# 30-015-43750 and the Armstrong 26/35 W1LM Federal Com #2H, API# 30-015-43798.

The Purple Sage Wolfcamp (Gas) Pool is currently governed by Special Pool Rules, Hearing Order No. R-14262 which requires standard 320-acre gas spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit, nor closer than 10 feet to any interior quarter-quarter section line or subdivision inner boundary, or in the case of a horizontal well, no closer than 330 feet to the outer boundary of the producing area.

The unorthodox location is necessary in order to maximize the recovery of oil and gas reserves from the Wolfcamp formation underlying the SE/4 of Section 26 and the E/2 of Section 35. Additionally, Devon and Mewbourne have agreed to grant each other waivers to NSL applications in the area in order to maximize the recovery of oil and gas reserves by extending the wellbores an additional 230 feet.

The affected offset acreage comprises the NE/4 of Section 26, T25S- R31E NMPM and the NE/4 of Section 2, T26S-R31E NMPM (See Attached Map). There is currently one Wolfcamp well producing within the offset acreage, Devon's Snapping 2 State #14H, API# 330-015-42688. Consequently, notice of this application is being provided to Devon Energy Production Company, LP and XTO Energy, Inc.

Attached is a Form C-102 showing the surface, first take point, and bottomhole locations for the Armstrong 26/35 W0JO Fed Com #4H. Also, attached is a map showing the affected offset acreage, a horizontal well plan, notice list and offset notice letter.

In summary, approval of the application will provide Mewbourne Oil Company the opportunity to recover additional oil and gas reserves from the Purple Sage Wolfcamp (Gas) Pool underlying Sections 26 and 35 that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.
