Tap Rock Operating, LLC ("Tap Rock") (OGRID No. 372043) seeks administrative approval of an unorthodox well location for its **Cypress 34 Federal #205H Well** (API No. 30-015-47267) to be completed within the Purple Sage; Wolfcamp Pool (98220) underlying the W/2 of Section 34, Township 23 South, Range 29 East, N.M.P.M., Eddy County, New Mexico.

This well will be drilled from a <u>surface location</u> 298 feet from the north line and 201 feet from the west line (Unit D) of Section 34, to a <u>bottom hole location</u> 30 feet from the south line and 990 feet from the west line (Unit M) of Section 34.

The <u>first take point</u> will be located 100 feet from the north line and 990 feet from the west line (Unit D) of Section 34 and the <u>last take point</u> will be 100 feet from the south line and 990 feet from the west line (Unit M) of Section 34.

Pursuant to Division Order R-14262, this acreage is governed by the Special Rules for the Purple Sage; Wolfcamp (Gas) Pool which provide for wells in the Wolfcamp formation in Eddy County to be located no closer than 330 feet to the outer boundary of the spacing unit.
