Tap Rock Operating, LLC ("Tap Rock") (OGRID No. 372043) seeks administrative approval of an unorthodox well location for its **Cypress 34 Federal #235H Well** (API No. 30-015-47264) to be completed within the Purple Sage; Wolfcamp Pool (98220) underlying the W/2 of Section 34, Township 23 South, Range 29 East, N.M.P.M., Eddy County, New Mexico.

This well will be drilled from a <u>surface location</u> 323 feet from the north line and 226 feet from the west line (Unit D) of Section 34, to a <u>bottom hole location</u> 30 feet from the south line and 1180 feet from the west line (Unit M) of Section 34.

The <u>first take point</u> will be located 100 feet from the north line and 1180 feet from the west line (Unit D) of Section 34 and the <u>last take point</u> will be 100 feet from the south line and 1180 feet from the west line (Unit M) of Section 34.

Pursuant to Division Order R-14262, this acreage is governed by the Special Rules for the Purple Sage; Wolfcamp (Gas) Pool which provide for wells in the Wolfcamp formation in Eddy County to be located no closer than 330 feet to the outer boundary of the spacing unit. The completed interval for the **Cypress 34 Federal #235H Well** will be unorthodox because it is closer than 330 feet to the northern and southern boundaries of the horizontal spacing unit. Approval of the unorthodox completed interval will allow Tap Rock to use its preferred well spacing plan for horizontal wells in this area and thereby prevent waste.





# LOCATION & ELEVATION VERIFICATION MAP





The Wells are located in the Purple Sage — Wolfcamp Gas Pool (Pool Code 98220). It is Tap Rock's responsibility as a prudent operator to maximize lateral length and to minimize reserves left in the ground. Decreasing the first and last take points will increase the Wells effective lateral length by 460 feet thereby increasing ultimate recovery of reserves and thereby preventing waste of natural resources.
