Tap Rock Operating, LLC ("Tap Rock") (OGRID No. 372043) seeks administrative approval of an unorthodox well location for its **Blue Marlin Fed Com #212H well** (API No. 30-025-49196) to be completed within the Jal; Wolfcamp, West Pool (33813) underlying the 640 acre, more or less, spacing unit in the W/2 of Sections 18 and 19, Township 25 South, Range 36 East, N.M.P.M., Lea County, New Mexico.

This well is to be drilled at the following location:

- <u>Surface location</u>: 285 feet from the south line and 2,225 feet from the west line (Unit N) of Section 19;
- <u>Bottom hole location</u>: 5 feet from the north line and 2,530 feet from the west line (Unit C) of Section 18;
- <u>First take point</u>: 100 feet from the south line and 2,530 feet from the west line (Unit N) of Section 19;
- <u>Last take point</u>: 100 feet from the north line and 2,530 feet from the west line (Unit C) of Section 18.

Since this acreage is governed by the Division's statewide rules, the completed interval for the **Blue Marlin Fed Com #212H well** is unorthodox because the completed interval is closer than the standard offsets to the eastern boundary of the spacing unit. Approval of the unorthodox

completed interval will allow Tap Rock to use its preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit A is a Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Blue Marlin Fed Com #212H well** encroaches on the spacing unit to the east in the W/2 E/2 of Sections 18 and 19. Also included with Exhibit A are the C-102s for each of the wells in the same spacing unit, including for the **Blue Marlin Fed Com #205H well**, which is the proximity tract well for the spacing unit. The spacing unit also includes the **Blue Marlin Fed Com #201H**, **#202H**, **#211H**, and **#215H wells**.

Exhibit B is a land plat that shows the proposed **Blue Marlin Fed Com #212H well** in relation to the adjoining spacing units to the east in the W/2 E/2 of Sections 18 and 19.

Ownership is diverse between the subject spacing unit and the affected spacing unit to the east. **Exhibit C** includes the tracking information that reflects the "affected parties" were sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. 
