Spur Energy Partners LLC respectfully requests administrative approval of a non-standard location on Halberd 27 State Com 50H, API Number 30-015-Pending, Property Code Pending. The 50H well is proposed to be completed in the Artesia; Glorieta-Yeso pool, Pool Code 96830. The proposed wellbore is to be completed within 330’ feet of the N/2 of the N/2 of Section 27. The proposed interval is projected as follows:

Surface Hole – 2220’ FNL 745’ FWL Unit E Sec 26 T17S R28E
First Take Point – 1575’ FNL 100’ FEL Unit H Sec 27 T17S R28E
Last Take Point – 1575’ FNL 100’ FWL Unit E Sec 27 T17S R28E
Bottom Hole – 1575’ FNL 50’ FWL Unit E Sec 27 T17S R28E

The adjoining units which the unorthodox location encroaches are located in T17S R28E, Section 27, Units A, B, C and D.

Approval of the unorthodox, completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.
