Spur Energy Partners LLC respectfully requests administrative approval of a non-standard location on Halberd 27 State Com 51H, API Number 30-015-Pending, Property Code Pending. The 51H well is proposed to be completed in the Artesia; Glorieta-Yeso pool, Pool Code 96830. The proposed wellbore is to be completed within 330' feet of the S/2 of the S/2 of Section 27. The proposed interval is projected as follows:

Surface Hole – 1825' FSL 465' FEL Unit I Sec 28 T17S R28E
First Take Point – 1500' FSL 100' FWL Unit L Sec 27 T17S R28E
Last Take Point – 1500' FSL 100' FEL Unit I Sec 27 T17S R28E
Bottom Hole – 1500' FSL 50' FEL Unit I Sec 27 T17S R28E

The adjoining units which the unorthodox location encroaches are located in T17S R28E, Section 27, Units M, N, O and P.

Approval of the unorthodox, completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

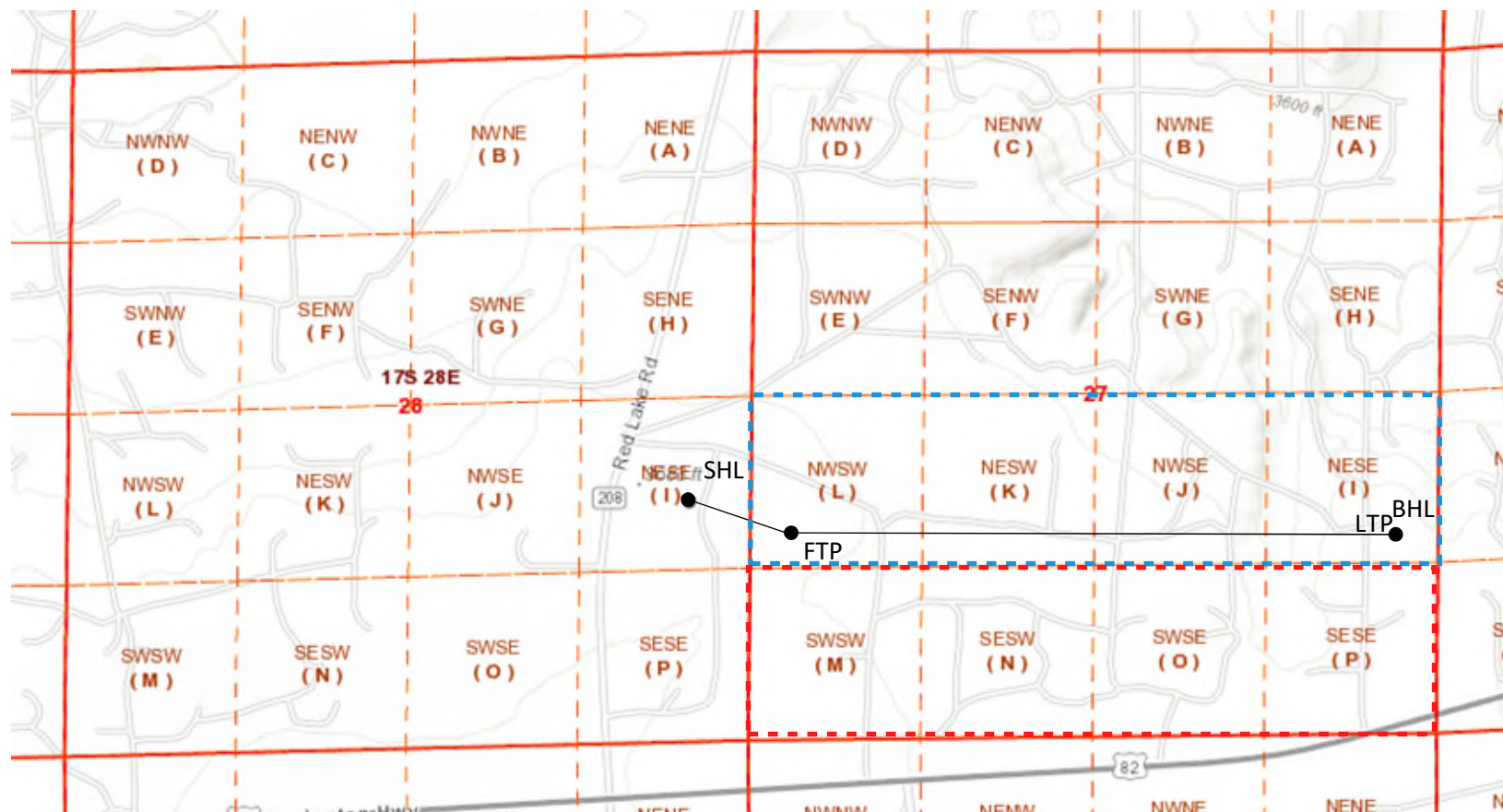
