Devon Energy Production Company, L.P., ("Devon"), OGRID No. 6137, is seeking administrative approval of an unorthodox well location ("NSL") for its EXMOOR 10-34 Fed Com 623H (API No. 30-015-Pending), gas well, covering 960-acres, to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying the E/2 of Sections 10 and 3, Township 25 South, Range 31 East, and the E/2 of Section 34, Township 24 South, Range 31 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit D. This is a horizontal well that will be drilled as follows:

EXMOOR 10-34 Fed Com 623H Well:

- Surface Location (SL): 316' from the South line and 1,397' from the East line of Section 10, Township 25 South, Range 31 East;

Devon has included as Exhibit C, a letter explaining why this application is needed. This well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). There are special pool rules for this pool under Order No. R-14262, that establish 330' setback requirements. The completed interval for the proposed well is closer than 330' from the boundary of the spacing unit.

The unorthodox well location will encroach towards the NE/4 of Section 15, Township 25 South, Range 31 East, and the SE/4 of Section 27, Township 24 South, Range 31 East.


