Centennial Resource Production, LLC (OGRID No. 372165), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13(C)-(D) NMAC and applicable rules governing acreage and well location requirements for the Ojo Chiso; Bone Spring pool [96553], seeks administrative approval of an unorthodox well location for its **Chimichangas 12 State Com #503H well** (API No. 30-025-49582), in a 640-acre, more or less, spacing unit underlying the E/2 of Sections 12 and 13, Township 22 South, Range 34 East, N.M.P.M., Lea County, New Mexico.

The proposed surface and bottom hole locations and first and last take points are as follows:

- the <u>surface location</u> is located 930 feet from the north line and 1244 feet from the east line (Unit A) of Section 12,
- the <u>bottom hole location</u> is located 187 feet from the south line and 325 feet from the east line (Unit P) of Section 13,
- the <u>first take point</u> is located 158 feet from the north line and 352 feet from the east line (Unit A) of Section 12 and

• the <u>last take point</u> is located 187 feet from the south line and 325 feet from the east line (Unit P) of Section 13.

Additionally, as shown by Exhibit A, some steering difficulties were encountered resulting in portions of the completed interval for this well extending past the 50-foot buffer for its 330-foot permitted location. In its most deviated location, the completed interval is 212 feet from the east line (Unit H) of Section 12.

Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because it is more than 50 feet closer to the outer boundary of the spacing unit than the approved location and is closer than the standard offsets to the eastern boundary of the spacing unit – thus encroaching on the W/2 of Sections 7 and 18, Township 22 South, Range 35 East. Approval of the unorthodox, completed interval will allow Centennial to use its preferred well spacing plan for horizontal wells in this area and prevent substantial costs related to redrilling the well, thereby maximizing recovery and preventing waste.

Exhibit A is a Form C-102 showing the completed interval of the proposed Chimichangas 12 State Com #503H well encroaches on the spacing unit/tracts to the east in the W/2 of Sections 7 and 18, Township 22 South, Range 35 East.

Exhibit B is a plat for the E/2 of Sections 12 and 13, Township 22 South, Range 34 East, and the W/2 of Sections 7 and 18, Township 22 South, Range 35 East, that shows the proposed Chimichangas 12 State Com #503H well in relation to adjoining spacing unit/tracts to the east. As shown on the plat, the affected spacing unit to the east is owned by Centennial, Atlas OBO Energy, LP, and EOG Resources, Inc. as working interest owners. In addition, the plat identifies that these are State leases. Accordingly, the "affected persons" ¹ are the applicant, Centennial Resource Production, LLC, Atlas OBO Energy, LP, EOG Resources, Inc., and the New Mexico State Land Office.

Exhibit C is a spreadsheet listing all affected persons and includes tracking information demonstrating that each of the affected persons was sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. 
