• the <u>last take point</u> is located 100 feet from the south line and 1650 feet from the east line (Unit O) of Section 33.

Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because the first and last take points are closer (100 feet instead of 330 feet) than the standard offsets to the northern and southern boundaries of the spacing unit – thus encroaching on (1) the SW/4 and W/2 SE/4 of Section 28, Township 23 South, Range 29 East, and (2) the N/2 of Section 4, Township 24 South, Range 29 East. Approval of the unorthodox, completed interval will increase the well's effective lateral length by 460 feet, thereby increasing ultimate recovery of reserves and preventing waste of natural resources.





LOCATION & ELEVATION VERIFICATION MAP






