(OGRID No. 4323), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the WC-025 G-06 S253209L; Bone Spring pool [96715], seeks administrative approval of an unorthodox well location for its **CO Grizzly 3 34 Fed 405H well** (API No. 30-025-49783), in a 640-acre, more or less, spacing unit underlying the W/2 of Section 34, T24S, R32E, and W/2 of Section 3, T25S, R32E, Lea County, New Mexico.

The proposed location is as follows:

- Surface location: 240' FNL and 1565' FWL (Unit C) of Section 10
- Bottom hole location: 25' FNL and 1210' FWL (Unit D) of Section 34
- First take point: 25' FSL and 1210' FWL (Unit M) of Section 3

the spacing unit – thus encroaching on the N/2NW/4 of Section 10, T25S, R32E. Approval of the unorthodox, completed interval will allow Chevron to use its preferred well spacing plan for horizontal wells in this area, which will maximize recovery and prevent waste.

Exhibit A is a Form C-102 showing the proposed CO Grizzly 3 34 Fed 405H well encroaches on the spacing unit/tracts to the south in the N/2NW/4 of Section 10, T25S, R32E.

Exhibit B is a plat showing the proposed CO Grizzly 3 34 Fed 405H well in relation to adjoining spacing unit/tracts to the south.
