Well allocation will be done following the same protocol approved under the existing commingling order: Oil and gas will flow to a wellbore test separator. Oil is measured via coriolis flow meter on each individual well and gas is measured by an orifice meter on each individual well and supporting EFM equipment according with API Chapter 21.1 before production is metered. Oil and Gas is calibrated periodically by a third party measurement company for accuracy. Commingled commingled production will be located in the NW/4NW/4 Section 20 T24S-R33E. C-102s and facility location plats are attached.

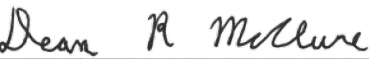
