Steward Energy II, LLC ("Steward") respectfully requests administrative approval of a non-standard location for the well referenced above. Said well was completed in the Bronco, San Andres, South Pool, Pool Code 7500, with rules specifying the completed interval must be located 330 feet from the exterior boundary of the applicable spacing unit. The proposed completed interval is as follows:

Surface: 670' FSL & 1430' FEL – Unit O, Sec. 15, T13S-R38E  
FTP: 103' FNL & 1441' FEL – Sec. 22, T13S-R38E  
LTP: 137' FSL & 1447' FEL – Sec. 22, T13S-R38E  
Bottom Hole: 48' FSL & 1450' FEL – Unit O, Sec. 22, T13S-R38E

The adjoining units towards which the unorthodox location encroaches are located in Sec. 22, T13S R38E - Units A, H, I, and P.

Approval of the unorthodox completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.
