Dear Director Sandoval,

EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its Stark 33 Fed Com No. 706H well (API No. 30-015-48603; sundry approval pending). The spacing unit dedicated to the well is comprised of the E/2 of Sections 5 and 8, and the W/2 of Sections 4 and 9, Township 26 South, Range 30 East, Eddy County, New Mexico and is within the Purple Sage; Wolfcamp pool (98220). The horizontal spacing unit for the well is approximately 1280 acres, which includes proximity tracts. The defining well for the spacing unit is the Stark 33 Fed Com No. 721H well (API No. 30-015-48598; sundry approval pending).

This well has not yet been drilled. It is proposed to be drilled as follows:

- The surface location is located 500 feet from the South line, 1832 feet from the West line (Unit N) of Section 33, Township 25 South, Range 30 East,
- The bottom hole location is located 100 feet from the South line, 2210 feet from the West line (Unit N) of Section 9,
- The first take point is located 330 feet from the North line, 2210 feet from the West line (Unit C) of Section 4,
- The last take point is located 100 feet from the South line, 2210 feet from the West line (Unit N) of Section 9.

The acreage is governed by the Purple Sage; Wolfcamp pool rules set forth in Division Order No. R-14262, which provides for 320-acre spacing units and 330-foot setbacks. Accordingly, the

proposed completed interval is unorthodox because it will be closer than 330 feet to the southern boundary of the spacing unit. It encroaches on the acreage including the N/2 of Section 16. Approval of the unorthodox location will allow EOG to use its preferred last take points for horizontal wells in this area, which will maximize recovery and prevent waste. The first take point will remain at an orthodox location for ownership reasons to the north.

Exhibit A is the C-102 sundry pending approval with the BLM. This plat shows the location of the proposed well, including the proposed unorthodox completed interval. The proposed completed interval encroaches on the tract to the south. The second page of Exhibit A is the approved APD showing the designated pool and API number.

Exhibit B is a plat that shows the Stark 33 Fed Com No. 706H well in relation to the adjoining spacing units/tracts to the south. EOG is the sole working interest owner in the N/2 of Section 16. Accordingly, the party entitled to notice is the State Land Office.



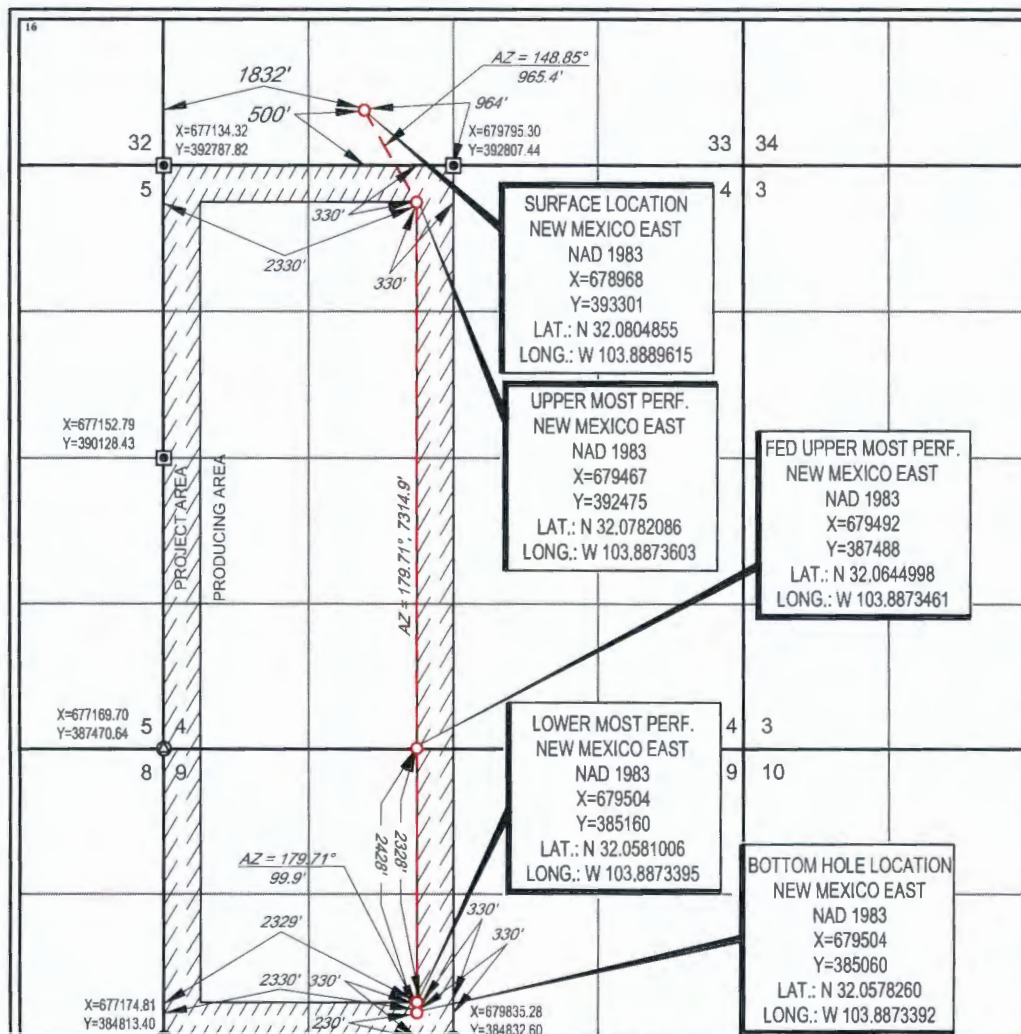

EOG Resources respectfully requests administrative approval of a nonstandard location for each of the Stark wells referenced above. The Stark wells are in the Purple Sage Wolfcamp Gas Pool (Pool Code 98220). As a prudent operator, EOG request that a non-standard location be granted for these wells. By decreasing the last take point from 330' to 100' the effective lateral length of the wells will be increased by 230' for each well, thereby increasing the ultimate recovery from the acreage and reducing resource wastage.
