Dear Mr. McClure:

FAE II Operating LLC, OGRID: 329326, requests administrative approval for surface commingling of gas production from the Jalmat Pool for its Double SS #2, Harrison #1, Harrison #2, Watkins #3 and Woolworth #1 wells located in Section 35, T-24S, R-36E as shown on the map in Exhibit A. The wells are located on separate leases. Exhibit B offers further detail on the relevant wells on the leases.

The attached battery diagrams, Exhibits C and D, are accurate schematics of the current facility and the proposed commingled facility, respectively. The Watkins #3 will have a gas allocation meter manufactured and assembled in accordance with American Gas Association specifications. The Double SS #2, Harrison #1, Harrison #2, and Woolworth #1 gas production will be determined by estimation, as these wells make less than 15 Mcf/d. New gas flowlines will be laid on the Double SS and Harrison leases and tied in to the Watkins #3 CRP.

After a review of internal records, the interest owners are not identical for the wells mentioned above. As such, we have notified all relevant parties of our intent to commingle production (see attached letter). The working and royalty interest owners as shown in Exhibit E have been notified of this application by certified mail. Copies of the certified mail receipts are attached as Exhibit F.

This proposed commingling of production is in the interest of conservation and will not result in reduced royalty or improper measurement of production. Exhibit A – Lease Boundaries Map

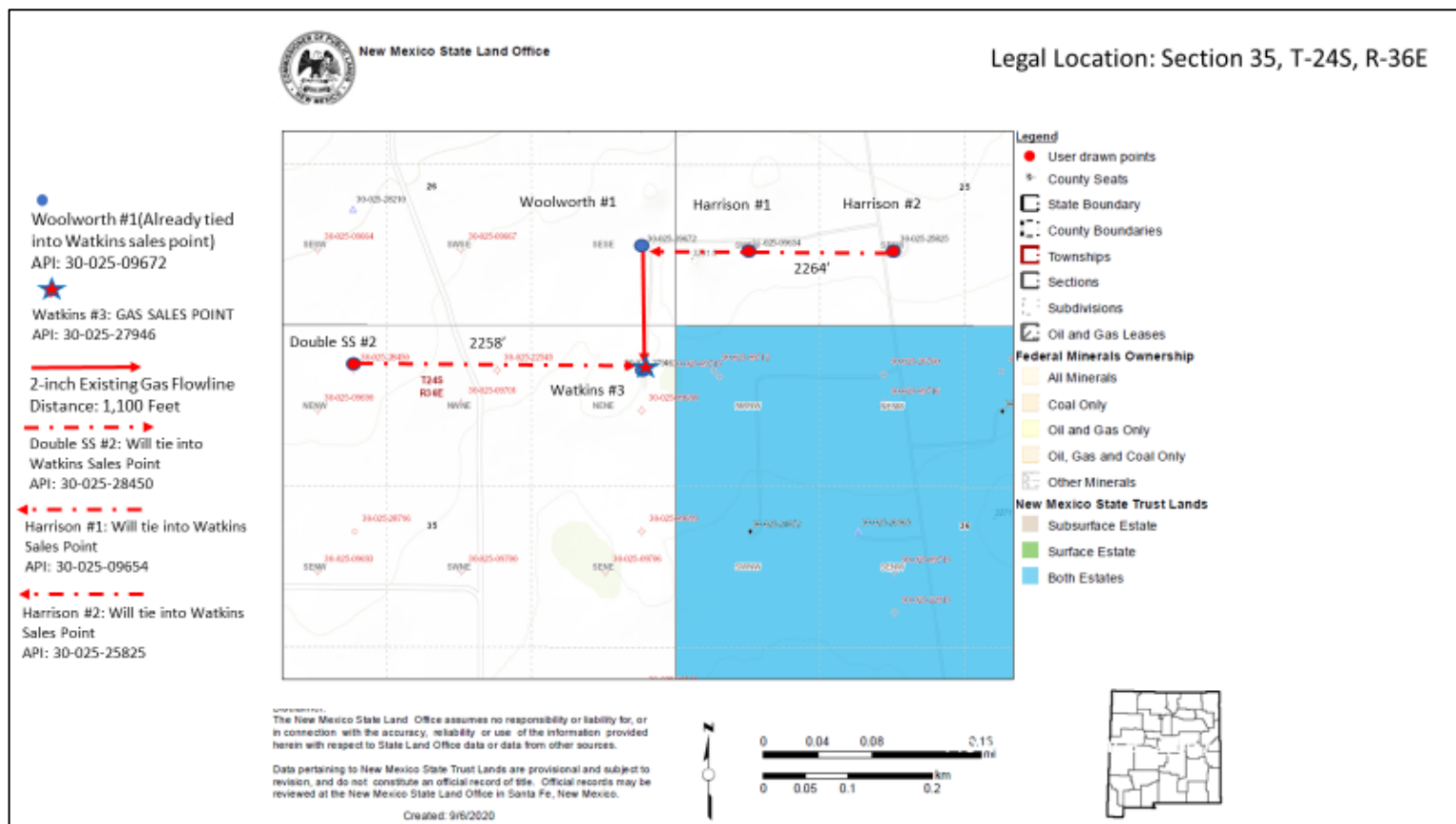
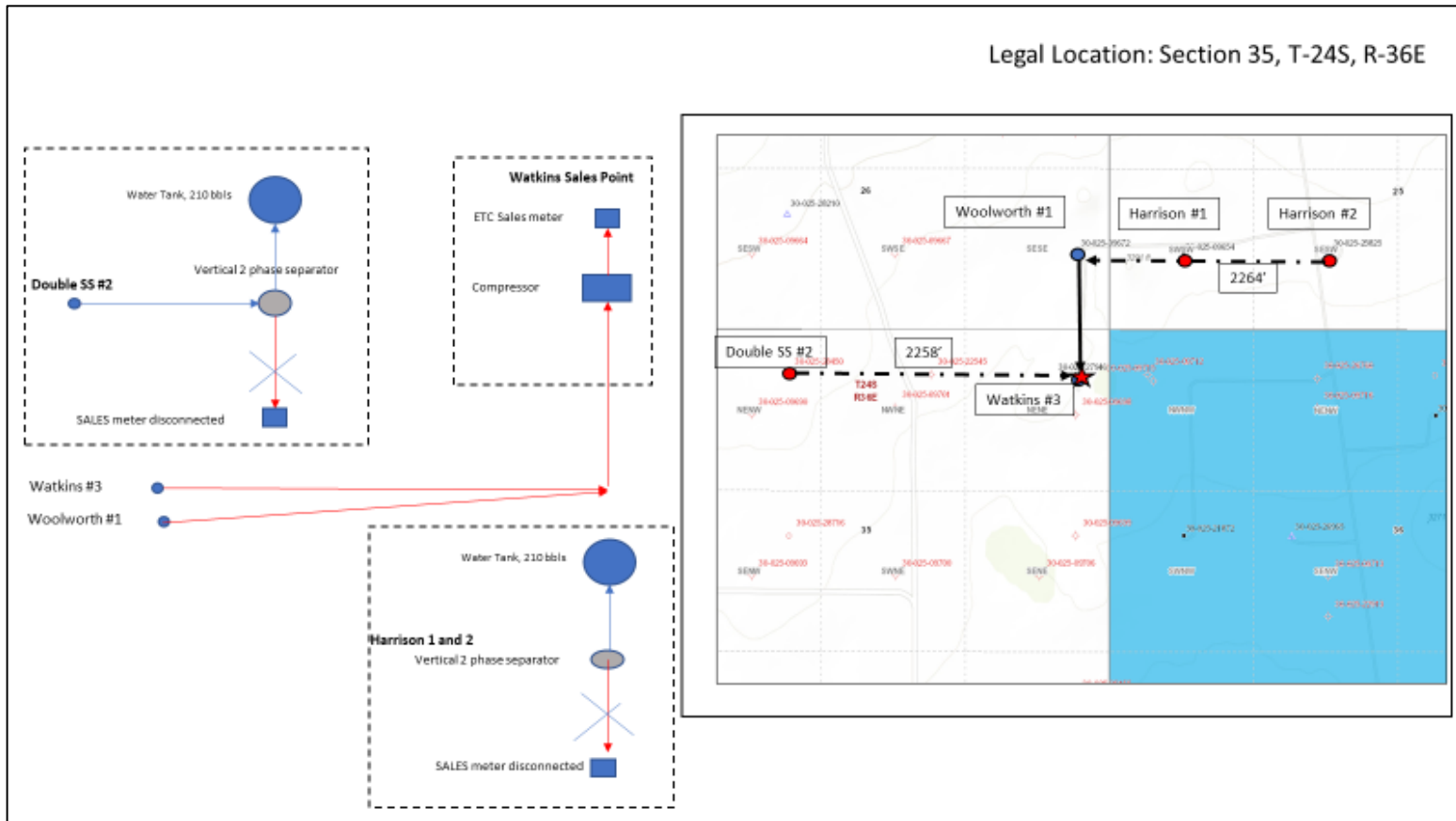

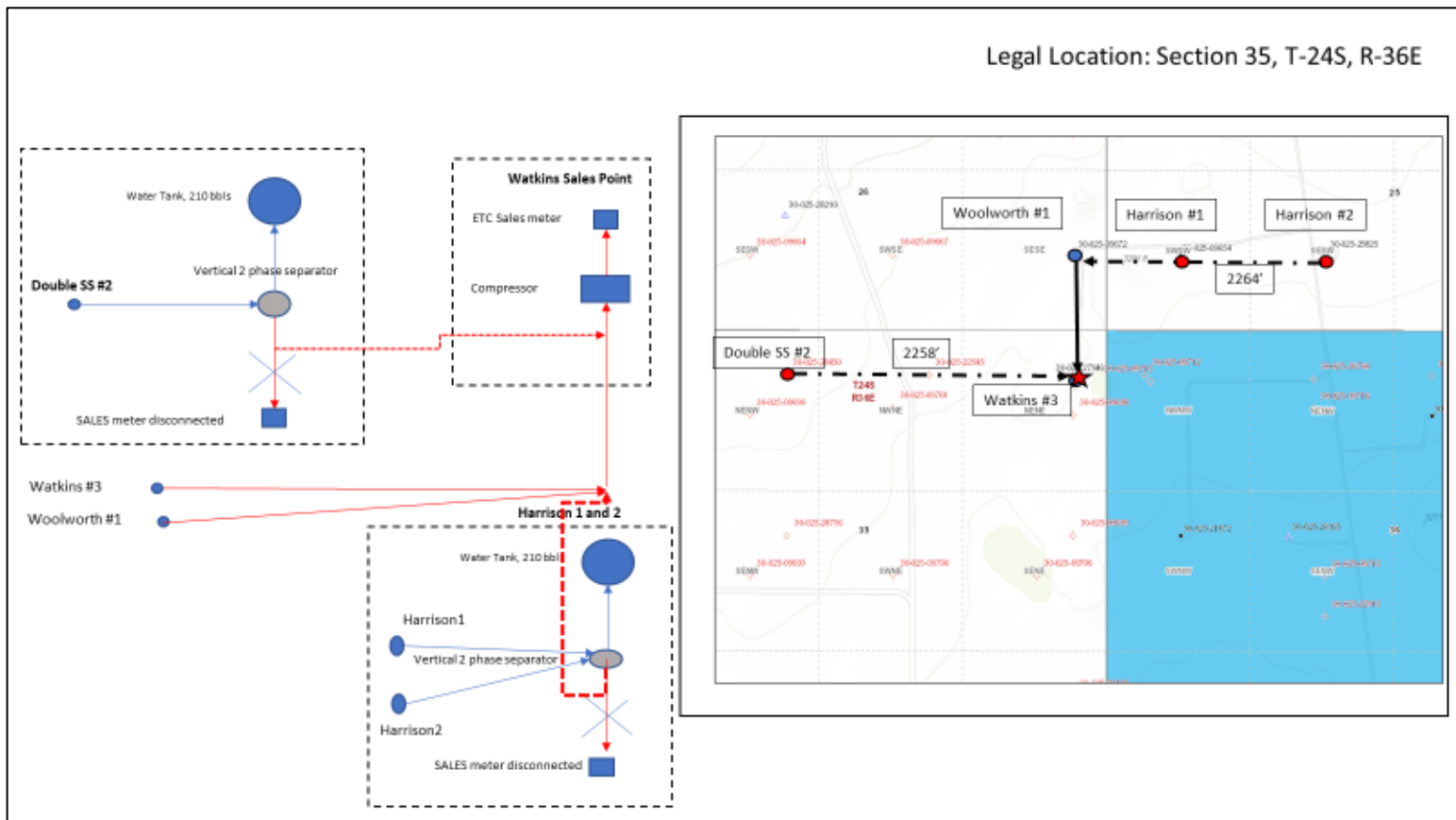
